- ***An individual must file The Summary Financial Statement of Candidate for the Office of Member of an Advisory Neighborhood Commission (ANC) within 60 days after certification by the D.C. Board of Elections , of the ANC election results.***
- ***The Summary Financial Statement of Candidate for the Office of Member of an Advisory Neighborhood Commission (ANC) must be filed in an electronic format at the OCF Website.***

## YOU ARE AN ANC CANDIDATE IF..

You qualify for the ballot, by the write-in, nominating or vacancy-filling process, in accordance with the regulations of the D.C. Board of Elections; or you accepted contributions or made expenditures and did not qualify for the ballot.

File The Summary Financial Statement of Candidate for the Office of Member of an Advisory Neighborhood Commission (ANC) no later than sixty (60) days after the BOE certifies any ANC election by write-in, nominating or vacancy-filling process; or, if you did not qualify for the ballot and you accepted contributions or made expenditures in pursuit of your candidacy.

## REPORTING REQUIREMENTS

The Summary Financial Statement represents the certified record of your contributions and expenditures, if any. No person shall make a contribution in support of an ANC candidate that exceeds \$25.00; and, an ANC candidate may make unlimited contributions to his or her campaign. However, the candidate must report all contributions and expenditures on the Summary Financial Statement; or, certify thereon that none was received or spent. The Summary Financial Statement must be filed online at the website of the Office of Campaign Finance.

**Note:** That there is a requirement to advise the Office of Campaign Finance as to the disposal of surplus contributions, if any.

## FYI

Occasionally, an ANC candidate may opt to open a principal campaign committee (PCC). Although it was never envisioned by the statute that an ANC candidate may wish to campaign through a PCC, OCF has permitted same and recommends a review of The PCC Publication brochure at this website. Moreover, in those instances when an ANC distributes campaign literature, any and all campaign literature is subject to the disclaimer requirements of the Campaign Finance.
