- III. That if certified, I will only run during that election cycle for the seat for the covered office for which I am seeking certification, including in both the primary and general elections.
- IV. That I have or otherwise will be qualified or will take steps to qualify for ballot access in accordance with the procedures required by the Board of Elections such as filing a declaration of candidacy and a nominating petition containing the required number of valid signatures.
- V. That I am current with respect to any fines or penalties owed for a violation of the Fair Elections Act.
- VI. That I have responded and will respond to all inquiries of the Board of Elections and Office of Campaign Finance in a timely manner.
- VII. I understand that Mayoral candidates must receive at least 1,000 individual small-dollar contributions that do not exceed \$200 each from individual District residents and total \$40,000 in the aggregate.
- VIII. I understand that Attorney General candidates must receive at least 500 individual small-dollar contributions that do not exceed \$200 from individual District residents and total \$20,000 in the aggregate.
- IX. I understand that Chairman of the Council candidates must receive at least 300 individual small-dollar contributions that do not exceed \$250 each from individual District residents and total \$15,000 in the aggregate.
- X. I understand that At-Large Council candidates must receive at least 250 individual small-dollar contributions that do not exceed \$100 each from individual District residents and total \$12,000 in the aggregate.
- XI. I understand that Ward Council candidates and at-large State Board of Education seat candidates must receive 150 individual small-dollar contributions that do not exceed \$50 each from individual District residents and total \$5,000 in the aggregate.
- XII. I understand that Ward State Board of Education candidates must receive at least 50 individual small-dollar contributions that do not exceed \$20 from individual District residents and total \$1,000 in the aggregate.
