**Community Outreach**

OCF held a virtual informal training session on Wednesday, February 21st, 2024 to discuss the Agency's Traditional and Fair Elections Programs.

**FAIR ELECTIONS PROGRAM DIVISION**

The following is an accounting of the FEP's production stats for February 2024:

**AUTHORIZED BASE AMOUNT AND MATCHING PAYMENTS**

**2020 Election Cycle.** By way of background, the 2020 Election Cycle was the first election cycle during which the Fair Elections Program was fully implemented. The total sum of **\$4,016,797.64** was disbursed from the FAIR ELECTIONS FUND in BASE AMOUNT (\$1,120,000.00) AND MATCHING PAYMENTS (\$2,896,797.64) to the Thirty-Six (36) Candidates certified in the Fair Elections Program to participate in the June 2, 2020, Primary Election, the June 16, 2020, Special Election (also conducted during this timeframe), and the November 3, 2020, General Election. The 2020 Election Cycle closed on November 3, 2020, and the 2020 Special Election Cycle closed on June 16, 2020.

**2022 Election Cycle.** The Office of Campaign Finance authorized the total sum of **\$12,358,606.95** for disbursement from the FAIR ELECTIONS FUND in BASE AMOUNT (\$1,680,000.00) AND MATCHING PAYMENTS (\$10,678,606.95), to the Forty-Two (42) Candidates certified in the Fair Elections Program to participate in the June 21, 2022, Primary Election (Thirty-One (31) Candidates) and the November 8, 2022 General Election (Eleven (11) Candidates). The 2022 Election Cycle closed on November 8, 2022.

**2024 Election Cycle.** As of this date, there are thirteen (13) certified Participating Candidates in the Fair Elections Program, and the Office of Campaign Finance has authorized the disbursement of the total sum of \$1,582,578.95 from the Fair Elections Fund in Base Amount and Matching Payments.

6. The Wendell for Ward 7 Councilmember Committee, Principal Campaign Committee. Matching Payments in the amount of Two Thousand Six Hundred and Twenty-Five Dollars (\$2,625.00) were authorized for disbursement on February 6, 2024.
7. The Ebony Payne for Ward 7 2024, Principal Campaign Committee. Matching Payments in the amount of Thirty-Six Thousand Four Hundred and Twenty-Five Dollars (\$36,425.00) were authorized for disbursement on February 7, 2024.
8. The Wendell for Ward 7 Councilmember Committee, Principal Campaign Committee. Matching Payments in the amount of Twenty-Nine Thousand Five Hundred Dollars (\$29,500.00) were authorized for disbursement on February 12, 2024.
9. The Friends of Christina Henderson 2024, Principal Campaign Committee. Matching Payments in the amount of One Hundred Dollars (\$100.00) were authorized for disbursement on February 12, 2024.
10. Rodney Grant, the Rodney “Red” Grant for City Council, Principal Campaign Committee. The Candidate Rodney Grant was certified on February 15, 2024 to participate in the Fair Elections Program in the June 4, 2024 Primary Election. Matching Payments in the amount of Seventy-Six Thousand Four Hundred Ninety-Three Dollars and Thirty-Five Cents

(\$76,493.35) and the first half of the Base Amount Payment in the amount of Twenty Thousand Dollars (\$20,000.00) were authorized for disbursement.

11. Paul Johnson, the Committee to Elect Paul Johnson 2024, Principal Campaign Committee. The Candidate Paul Johnson was certified on February 16, 2024 to participate in the Fair Elections Program in the June 4, 2024 Primary Election. Matching Payments in the amount of Twenty-Eight Thousand Seven Hundred Seventy-Five Dollars (\$28,775.00) and the first half of the Base Amount Payment in the amount of Twenty Thousand Dollars (\$20,000.00) were authorized for disbursement.
12. Lisa Gore, the Friends of Lisa Gore 2024, Principal Campaign Committee. The Candidate Lisa Gore was certified on February 23, 2024 to participate in the Fair Elections Program in the June 4, 2024 Primary Election. Matching Payments in the amount of Thirty-Four Thousand Five Hundred and Forty Dollars (\$34,540.00) and the first half of the Base Amount Payment in the amount of Twenty Thousand Dollars (\$20,000.00) were authorized for disbursement.
13. The Elect Eboni-Rose Thompson 2024, Principal Campaign Committee. Matching Payments in the amount of Thirty-Six Thousand and Six Hundred Dollars (\$36,600.00) were authorized for disbursement on February 23, 2024.
14. The Friends of Salim Adofo, Principal Campaign Committee. Matching Payments in the amount of Twenty-One Thousand Two Hundred and Thirty Dollars (\$21,230.00) were authorized for disbursement on February 23, 2024.
15. The Re-Elect Robert White 2024, Principal Campaign Committee. Matching Payments in the amount of One Hundred Fifteen Thousand Four Hundred Eighty-Five Dollars (\$115,485.00) were authorized for disbursement on February 23, 2024.

As of February 2024, the total sum of **\$803,207.20** has been remitted for deposit in the Fair Elections Fund from the campaign operations of Participating Candidates in the 2022 Election Cycle.

## **ONGOING 2020 POST-ELECTION FULL FIELD AUDITS**

The 2020 Election Cycle. The following Ten (10) Post-Election Audits are currently ongoing before the Fair Elections Program at various stages, including Audit Documentation received and Audit in progress; Audit Complete and the Preliminary Statement of Findings issued, and/or Response received and Under Review/Draft Final Audit submitted to the Audit Manager and Under Review; and Failure to submit Audit Documentation and Referred to the Office of the General Counsel (OGC). The FEP Division has issued a total of Twenty-Four (24) Final Audit Reports of the Post-Election Audits initiated for the 2020 Election Cycle, including the Final Compliance Audit Report issued on February 23, 2024, in the Kelvin Brown for DC Council Ward 7 Principal Campaign Committee.

**Post-Election Audits – The June 2, 2020, Primary Election** (Audits initiated on June 19, 2020, of the Campaign Operations of those Candidates who did not proceed to the General Election):

1. Green for Ward 7 – Audit documentation received on August 6, 2020. Draft Final Statement of Audit Findings submitted to FEP Manager for review.
2. Kelvin Brown for DC Council Ward 7 – Partial Audit documentation received June 23, 2021. Referred to OGC for action on May 23, 2022 concerning the remaining requested records. The Hearing was held on January 31, 2024, as to Audit documentation and the matter was continued until February 12, 2024, for the submission of the requested information. The **Final Compliance Audit was issued on February 23, 2024.**
3. Mike for Ward 8 – Audit complete. **Preliminary Statement of Finding issued on June 23, 2021.** Response submitted on July 14, 2021. Draft Final Statement of Audit Findings submitted to the FEP Manager for review.

The Office of Campaign Finance issued Forty-Two (42) Post-Election Audits Letters for the June 21, 2022, Primary Election and the November 8, 2022 General Election to Candidates who were certified to participate in the 2022 Election Cycle. (Audits initiated on March 13, 2023 and March 24, 2023). To date, the FEP has issued Twenty (20) Preliminary Statements of Audit Findings and Nineteen (19) Final Audit Reports for the 2022 Election Cycle.
