Public Library the time will be 2:00 p.m. until 3:00 p.m. Although the agenda for each session is predetermined, the facilitator may deviate from the stated content to address specific concerns of participants. If the need should arise for immediate, individualized training, you may make a special request with the General Counsel, who will attempt to accommodate the request in a timely manner.
